Chairman's Circular 13

Dear Parents,

Resignation of Members of Board of Directors of the Sri Lankan School – Muscat (SLSM)

We hereby inform you that on 20.05.2013, Hon. Secretary of the Board, Mr. Ravi Dharmawardane and Mr. Suranga Perera, resigned from the Board, citing no confidence on the Chairman of the Board with resignations effective 20.07.2013. Further Mr Ajantha Madurapperuma Hon. Treasurer, Mr Dunstan Sisira Kumara and Mr N L A Haleem informed the Board on 20.05.2013 that they have tendered their resignation to His Excellency, Sri Lankan Ambassador to the Sultanate of Oman, effective 20.07.2013, citing no confidence on the Chairman of the Board. His Excellency, Sri Lankan Ambassador to the Sultanate of Oman informed the Board on 21.05.2013 that resignation letters submitted by the members appointed by the embassy, Mr Ajantha Madurapperuma, Hon. Treasurer and Mr Dunstan Sisirakumara, were accepted by His Excellency. His Excellency further stated that the directorship of his representative Mr N. L. A. Haleem – Head of Chancery of the Embassy was withdrawn from the Board. The above resignations were duly accepted by the Board at the Board meeting held on 28.05.2013 and to take necessary action to fill the vacancies in terms of the constitution of the SLSM.

The School informed the Ministry of Education the resignations of the members and sought the ministry guidance on filling the vacancies for the remaining period to pave smooth functioning of the Board and the School. Meanwhile, the Board also agreed and appointed Mr Ratnasiri Jayasinghe as the Hon Secretary of the Board and Mr Wasantha De Zoysa as the Hon Treasurer with effect from 20.07.2013 to fill the vacancies created from above resignations.
